Dear Shareholder

Annual General Meeting

I am writing to you regarding the Company's annual general meeting ("**AGM**") which will be held at 8.30am on 16 May 2022. Details of the venue of the meeting are set out in the notice convening the AGM at the end of this letter.

COVID-19 and AGM proceedings

In the lead up to the AGM we are closely monitoring the impact of the ongoing COVID-19 outbreak and how this may affect arrangements for the AGM.

We are keen to ensure that the health and safety of our shareholders, directors, employees and other key stakeholders remains a priority and as such, in light of the increasing infection rates of COVID-19, **all shareholders are urged to appoint the Chairman of the meeting as their proxy, with voting instructions**. Please refer to the notes to the notice convening the AGM for more information regarding proxy voting.

If you are planning to attend the meeting in person please notify David Joseph, the Company Secretary, via shareholders@digitalbox.com in advance and note that in the interests of safety you may be refused entry if the numbers in attendance becomes unsafe, in the opinion of the Company.

You should not attend the AGM in person if you are experiencing any of the symptoms connected with COVID-19 or are otherwise required to isolate or quarantine. We will ask you to comply with all health and safety measures we put in place, which could include lateral flow tests before entering the venue, social distancing and wearing a face covering once inside. We will refuse entry if you are displaying any symptoms or are not complying with health and safety measures we put in place.

In light of the suggestion that shareholders appoint the Chairman of the meeting as their proxy, the AGM will only address the formal matters contained in the notice convening the AGM at the end of this letter.

We appreciate we are asking shareholders not to attend the AGM if it can be avoided and as such the Company is proposing to allow shareholders who will not attend the opportunity to raise any issues or concerns arising from the business proposed to be conducted at the meeting. Appropriate questions on the business of the meeting should be emailed to shareholders@digitalbox.com before 2:00 p.m. on 10 May 2022 and the Company will procure that responses, where deemed appropriate, will be posted on the Company's website, www.digitalbox.com/investors, as soon as practicable following the AGM. Please note, the Company must answer any such question relating to the business being dealt with at the meeting but no such answer need be given if (a) to do so would interfere unduly with the preparation for the meeting or involve the disclosure of confidential information, (b) the answer has already been given on a website in the form of an answer to a question, or (c) it is undesirable in the interests of the Company or the good order of the meeting that the question be answered.

The UK Government may implement further measures relating to the holding of general meetings or public health guidance may change prior to the AGM. Any changes to the AGM (including the arrangements outlined above) will be made available on the Company's website at www.digitalbox.com/investors and by means of the Regulatory Information Service.

Business to be transacted at the AGM

The resolutions to be proposed at the AGM are summarised below.

Resolutions 1 to 9 are proposed as ordinary resolutions. This means that for each of these resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolutions 10 and 11 are proposed as special resolutions. This means that for each resolution to be passed, at least three quarters of the votes cast must be in favour of the relevant resolution.

Resolution 1: Report and Accounts

The directors of the Company (the "**Directors**") will present their report and the annual accounts to the meeting. This gives shareholders the opportunity to ask questions on the content before voting on the resolution. A copy of the annual report and accounts is available on the Company's website at www.digitalbox.com/investors/documents&reports.

Resolutions 2, 3, 4, 5 and 6: Appointment of Director

Philip James Machray was appointed by the board as a director of the Company during the period between the Company's last annual general meeting and the date of the AGM and James Alexander Carter, James Robert Douglas, Martin James Higginson and David Joseph were appointed as directors at the annual general meeting held in July 2019 (each a "**Retiring Director**"). Consequently, it is proposed that in accordance with Article 79 of the current articles of association of the Company (the

"Articles"), each Retiring Director retires as a director and is subsequently re-elected as a director by ordinary resolution of the shareholders.

Resolution 7: Appointment of Auditors

An ordinary resolution will be proposed to re-appoint Haysmacintyre LLP as the Company's auditors to hold office from the conclusion of the AGM until the conclusion of the next general meeting at which accounts are laid before the members of the Company. This is recommended by the Audit Committee.

Resolution 8: Remuneration of the Auditors

An ordinary resolution will be proposed to authorise the Directors to determine the remuneration payable to the auditors.

Resolution 9: Directors' Authority to Allot Shares

This ordinary resolution seeks shareholder approval for the Directors to be authorised to allot shares. Under the provisions of section 551 of the Companies Act 2006 (the "Act"), the Directors are not permitted to allot shares unless authorised to do so by the shareholders. The Act provides for such authority to be granted either by the Company in general meeting or by the Articles and, in both cases, such authority must be renewed every five years. Notwithstanding the statutory provisions, in accordance with institutional best practice, it is the present intention of the Directors to seek a similar authority each year.

The Directors seek authority to allot shares in the capital of the Company up to a maximum nominal amount of £393,077.97 (representing one third of the issued ordinary share capital as at the date of this document). This will facilitate the raising of further funds and the making of investments and acquisitions in pursuit of the previously approved investing policy. This power will last until the conclusion of the next annual general meeting of the Company.

Resolution 10: Directors' Power to Dis-apply Pre-emption Rights

This resolution, which will be proposed as a special resolution, supplements the Directors' authority to allot shares in the Company proposed by resolution 9.

Section 561 of the Act requires a company proposing to allot equity securities (which includes selling shares held in treasury) to offer them first to existing shareholders in proportion to their existing shareholdings. Equity securities include ordinary shares, but do not include shares issued under employee share schemes. If resolution 10 is passed, the requirement imposed by section 561 of the Act will not apply to allotments by the Directors in two cases:

1. in connection with a rights (or similar) issue, where strict application of the principle in section 561 of the Act could (for example) either result in fractional entitlements to shares arising or require the issue of shares where this would be impractical because of local, legal or regulatory requirements in any given overseas jurisdiction; and

- allotments of shares for cash up to a total nominal value of £117,923.39 (representing ten per cent. of the issued ordinary share capital as at the date of this document). This gives the Directors flexibility to take advantage of business opportunities as they arise.

This authority will expire at the conclusion of the next annual general meeting except in so far as commitments to allot shares have been entered into before that date. It is the present intention of the Directors to seek a similar authority annually.

The Directors believe that this resolution together with resolution 9 will provide the Company with flexibility to take advantage of business opportunities that may arise.

Resolution 11: Adoption of new articles of association

Resolution 11 will be proposed as a special resolution to adopt new articles of association of the Company (the “**New Articles**”) to take effect from the conclusion of the AGM. The New Articles will amend the Company’s Articles to reflect changes to market practice around the holding of combined physical and electronic meetings, known as ‘hybrid’ meetings, and fully electronic meetings in the future. An amended copy of the New Articles, showing the proposed alterations, and a clean version of the New Articles, showing no alterations can be found at www.digitalbox.com/investors in accordance with Article 135.1.5 of the Articles.

The board believes that virtual and/or hybrid meetings will allow for greater shareholder and stakeholder engagement over the coming years in a way that is more convenient for all parties. The board believes this flexibility is particularly necessary at the moment given the ongoing uncertainty as regards the potential re-introduction of social distancing measures, restrictions on gatherings, and the need to maintain open channels of communication between shareholders, directors and stakeholders.

The New Articles will also allow the Company to provide shareholders with copies of the annual reports and accounts of the Company via electronic means and/or via publication on the Company’s website.

Action to be taken in the event that you cannot attend the AGM

If you do not intend to attend the AGM and you hold ordinary shares in certificated form, you are encouraged to complete the accompanying form of proxy and return it in accordance with the instructions printed thereon as soon as possible, but in any event so as to be received by post or, during normal business hours only, by hand, at Share Registrars Limited, 3 Millennium Centre, Crosby Way, Farnham, Surrey GU9 7XX, or by email at voting@shareregistrars.uk.com by no later than **8.30am on 12 May 2022** (or, in the case of an adjournment of the AGM, not later than 48 hours before the time fixed for the holding of the adjourned meeting (excluding any part of a day that is not a Business Day)).

If you hold your ordinary shares in the Company in uncertificated form (that is, in CREST) you may vote using the CREST Proxy Voting service in accordance with the procedures set out in the CREST Manual (please also refer to the accompanying notes to the notice of the AGM set out at the end of this letter). Proxies submitted via CREST must be received by the Company's agent (CREST ID: 7RA36) by no later than **8.30am on 12 May 2022** (or, in the case of an adjournment, not later than 48 hours before the time fixed for the holding of the adjourned meeting (excluding any part of a day that is not a Business Day)).



Notice is hereby given that the annual general meeting of Digitalbox plc (the "**Company**") will be held at Jubilee House, 92 Lincoln Road, Peterborough, PE1 2SN at 8.30am on 16 May 2022 to consider and, if thought fit, pass the following resolutions as ordinary resolutions other than resolutions 10 and 11 which will be proposed as special resolutions.

Ordinary Business

1. To receive the Company's accounts for the financial year ended 31 December 2021 together with the directors' report and the auditors' report thereon.
2. To re-elect Philip James Machray as a director of the Company ("**Director**").
3. To re-elect James Alexander Carter as a Director.
4. To re-elect James Robert Douglas as a Director.
5. To re-elect Martin James Higginson as a Director.
6. To re-elect David Joseph as a Director.
7. To appoint Haysmacintyre LLP as the auditors of the Company.
8. To authorise the Directors to agree the remuneration of the auditors of the Company.
9. That the Directors be generally and unconditionally authorised for the purpose of section 551 of the Companies Act 2006 (the "**Act**") to exercise all the powers of the Company to allot or grant rights to subscribe for or to convert any security into shares in the Company up to an aggregate nominal amount of £393,077.97 provided that:
 - 9.1 (except as provided in paragraph 9.2 below) this authority shall expire on the date of the next annual general meeting of the Company; and
 - 9.2 the Company may before such expiry make an offer or agreement which would or might require shares or equity securities, as the case may be, to be allotted or such rights granted after such expiry and the Directors may allot shares or equity securities or grant such rights, as the case may be, in pursuance of such offer or agreement notwithstanding that the authority conferred by this resolution has expired.

All unexercised authorities previously granted to the Directors to allot shares or to grant rights to subscribe for or to convert any security into shares be and are hereby revoked.

Special Business

10. That, subject to the passing of resolution 9 above, the Directors, pursuant to the general authority conferred on them, be empowered pursuant to section 570 of the Act to allot for cash, either pursuant to the authority so conferred or where the equity securities are held by the Company as treasury shares (within the meaning of section 724(5) of the Act), equity securities (within the meaning of section 560 of the Act) as if section 561 of the Act did not apply to any such allotment provided that this power shall be limited to the allotment of equity securities:

10.1 made in connection with an offer of securities, open for acceptance for a fixed period, by the Directors to holders of ordinary shares of the Company on the register on a fixed record date in proportion (as nearly as may be) to their then holdings of such shares (but subject to such exclusions or other arrangements as the Directors may deem necessary or expedient to deal with treasury shares or any legal or practical problems under the laws or requirements of any recognised regulatory body or any stock exchange in any overseas territory or in connection with fractional entitlements) or by virtue of shares being represented by depositary receipts or any other matter whatsoever; and/or

10.2 wholly for cash (otherwise than pursuant to paragraph 10.1 above) up to an aggregate nominal value of £117,923.39,

and shall expire on the conclusion of the next annual general meeting of the Company but the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities pursuant to such an offer or agreement notwithstanding that the power conferred by this resolution has expired.

All unexercised authorities previously granted to the Directors under section 570 of the Act are hereby revoked.

11. That with effect from conclusion of the AGM the draft articles of association of the Company produced to the meeting and initialled by the Chair of the meeting for the purpose of identification, be adopted as the articles of association of the Company in substitution for, and to the exclusion of, the Company's existing articles of association.

Notes

The following notes explain your general rights as a member of the Company and your right to attend and vote at this meeting or to appoint someone else to vote on your behalf.

1. Pursuant to Regulation 41 of Uncertificated Securities Regulations 2001, the Company specifies that only those members entered in the register of members of the Company as at 8.30am (BST) on 12 May 2022 shall be entitled to attend and vote at the meeting convened above in respect of the number of shares registered in their names at that time. This time will still apply for the purpose of determining who is entitled to attend and vote if the annual general meeting is adjourned from its scheduled time by 48 hours or less. If the annual general meeting is adjourned for longer, members who wish to attend and vote must be on the Company's register of members by 48 hours (excluding any part of a day that is not a business day) before the time fixed for the adjourned meeting. Changes to entries on the register of members after that time will be disregarded in determining the rights of any person to attend or vote at the meeting.
2. A member entitled to attend and vote at the meeting convened by the above notice is entitled to appoint another person as his proxy to exercise all or any of his rights to attend and to speak and vote at the meeting. On a poll demanded, all of a member's voting rights may be exercised by one or more duly appointed proxies. Any such member may appoint more than one proxy provided that each proxy is appointed to exercise the rights attached to a different share or shares held by such member. You may not appoint more than one proxy to exercise rights attached to any one share. A proxy must vote in accordance with any instructions given by the appointing member. To appoint more than one proxy, please contact Share Registrars Limited, 3 Millennium Centre, Crosby Way, Farnham, Surrey, GU9 7XX or by email at voting@shareregistrars.uk.com. A proxy need not be a member of the Company, but they must attend the meeting to represent the relevant member. Appointing a proxy will not prevent a member from attending in person and voting at the meeting. If you wish your proxy to speak on your behalf at the meeting you will need to appoint your own choice of proxy (not the chairman of the meeting) and give your instructions directly to them.
3. A form of appointment of proxy is enclosed. Please carefully read the instructions on how to complete the form of proxy. To appoint a proxy using this form in hard copy form, this form must be completed and signed, sent or delivered by post to Share Registrars Limited, 3 Millennium Centre, Crosby Way, Farnham, Surrey, GU9 7XX or by e-mail at voting@shareregistrars.uk.com. In the case of a member which is a company, the proxy form must be executed under its common seal or signed on its behalf by an officer of the company or an attorney of the company. If you return more than one proxy appointment, either by hard copy form or by electronic form, that received last by the registrar before the latest time for the receipt of proxies will take precedence. The completion and return of a form of proxy does not preclude a member from subsequently attending and voting at the meeting in person if he or she so wishes. If a member has appointed a proxy and attends the meeting in person, such proxy appointment will automatically be terminated.

4. CREST members who wish to appoint a proxy or proxies through the CREST Electronic Proxy Appointment Service may do so for the meeting to be held at 8.30am (BST) on 16 May 2022 (and any adjournments thereof) by following the procedures described in the CREST manual. All messages relating to the appointment of a proxy or an instruction to a previously-appointed proxy, which are to be transmitted through CREST, must be received by the Registrars (ID 7RA36) no later than 8.30am (BST) on 12 May 2022, or, if the meeting is adjourned, 48 hours before the time fixed for the adjourned meeting (excluding any part of a day that is not a business day). Please note the following:
 - 4.1 in order for a proxy appointment or instruction made using the CREST service to be valid, the appropriate CREST message (a "**CREST proxy instruction**") must be properly authenticated in accordance with Euroclear UK & Ireland Limited's specifications and must contain the information required for such instructions, as described in the CREST manual. The message, regardless of whether it constitutes the appointment of a proxy or is an amendment to the instruction given to a previously appointed proxy must, in order to be valid, be transmitted so as to be received by the issuer's agent by the latest time(s) for receipt of proxy appointments specified in this notice. For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp applied to the message by the CREST application host) from which the issuer's agent is able to retrieve the message by enquiry to CREST in the manner prescribed by CREST. After this time any change of instructions to proxies appointed through CREST should be communicated to the appointee through other means;
 - 4.2 CREST members and, where applicable, their CREST sponsors or voting service providers should note that Euroclear UK & Ireland Limited does not make available special procedures in CREST for any particular messages. Normal system timings and limitations will therefore apply in relation to the input of CREST proxy instructions. It is the responsibility of the CREST member concerned to take (or, if the CREST member is a CREST personal member or sponsored member or has appointed a voting service provider(s), to procure that his CREST sponsor or voting service provider(s) take(s)) such action as shall be necessary to ensure that a message is transmitted by means of the CREST system by any particular time. In this connection, CREST members and, where applicable, their CREST sponsors or voting service providers are referred in particular to those sections of the CREST manual concerning practical limitations of the CREST system and timings; and
 - 4.3 the Company may treat as invalid a CREST proxy instruction in the circumstances set out in regulation 35(5)(a) of the Uncertificated Securities Regulations 2001.
5. A member's instructions to the proxy must be indicated in the appropriate space provided. The form of proxy includes a vote withheld option. To abstain from voting on a resolution, select the relevant 'Vote withheld' box. Please note that a vote withheld is not a vote in law and will not be counted in the calculation of the proportion of the votes for and against any particular resolution. If no voting indication is given, your proxy will vote or abstain from voting at his or her decision. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting.

6. The form of proxy must be signed by the appointor or his attorney duly authorised in writing. The appointment of a proxy and the original or duly certified copy of the power of attorney or other authority (if any) under which it is signed or authenticated should be deposited with the Company's registrar at the address shown on the proxy form not later than 8.30am (BST) on 12 May 2022 or 48 hours (excluding any part of a day that is not a business day) before the time for holding any adjourned meeting or (in the case of a poll not taken on the same day as the meeting or adjourned meeting) for the taking of the poll at which it is to be used.
7. As at the close of business on the date immediately preceding this notice, the Company's issued share capital comprised 117,923,393 ordinary shares. Only the ordinary share carries the right to vote at the meeting and, therefore, the total number of voting rights in the Company as at close of business on the date immediately preceding this notice is 117,923,393.
8. In the case of joint holders of shares, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first named being the most senior).
9. Any corporation which is a member can appoint one or more corporate representatives who may exercise on its behalf all of its powers as a member provided that they do not do so in relation to the same shares.
10. In order to revoke a proxy instruction you will need to inform the Company by sending a signed hard copy notice clearly stating your intention to revoke your proxy appointment to the Company's registrars. In the case of a member which is a company, the revocation notice must be executed in accordance with note 9 above. Any power of attorney or any other authority under which the revocation notice is signed (or a duly certified copy of such power or authority) must be included with the revocation notice and must be received by the Company's registrars not less than 48 hours (excluding any part of a day that is not a business day) before the time fixed for the holding of the meeting or any adjourned meeting (or in the case of a poll before the time appointed for taking the poll) at which the proxy is to attend, speak and to vote. If you attempt to revoke your proxy appointment but the revocation is received after the time specified then, subject to the paragraph directly below, your proxy appointment will remain valid.
11. Except as provided above, members who have general queries about the meeting should contact the Company Secretary in writing at the Company's registered office. No other methods of communication will be accepted.
12. Each of the resolutions to be put to the meeting will be voted on a poll.
13. Copies of the articles of association of the Company, all service contracts of the directors employed by the Company and the letters of appointment of the non-executive directors of the Company are available for inspection by the members of the Company during normal business hours (Saturdays, Sundays and public holidays excepted) from the date of this notice until the close of the meeting.
